The two separate test wells both came back showing low quantity and unacceptable quality. That water was high in nitrates and very hard water. In order to solve the TTHM's and HAA5 issue Mountain Park has decided to install a treatment building to utilize chloramines to eliminate the out of compliance contamination issued by ODEQ's consent order. This should resolve the consent order requirements and return Mountain Park into full compliance with ODEQ standards. Adam made the motion to proceed with the Chloramine treatment for the water in Mountain Park, Phil 2<sup>nd</sup>.
